## Term Based Program Fees

### **School of Law LLM Program Fee**

- o This program is designed for foreign citizens who desire a background in the American legal system and consists of an additional 24 credit hours.
- o This program fee is billed in addition to charges for registration based tuition and fees for students enrolled in a Law term. Students will be billed this additional fee of up to \$9,000 per term for each fall, spring or summer semester.

### **School of Law Consortium Program Fee**

- o This program supports consortium teaching programs undertaken by the Law School. Such consortiums, or partnerships, allow the law school to offer learning opportunities (particularly in the area of international law) that would otherwise be unavailable to Texas Tech students. The program will consist of no more than 11 credit hours during the summer term.
- o Upon acceptance, each student is required to pay a deposit of up to \$500, within two weeks of acceptance, to hold their place in the program. This deposit will be applied as a credit during the student's final enrolled term and is otherwise refundable only under program guidelines.
- o Residents of Texas will be charged a flat fee of up to \$11,000 for the summer semester. Nonresidents will be charged the same program fee as residents plus the applicable state tuition surcharge rate per semester credit hour as authorized annually by the Texas Higher Education Coordinating Board.
